The Actor/Location waives all rights to inspect and approve the finished product, its use or such written or spoken copy as may be used in connection therewith.
- B. Actor/Location acknowledges that any pictures or voice recordings taken of Actor/Location on a film submitted to the Walnut Lane Film Festival and any pictures submitted by Actor/Location are or will become the sole property of the Princeton Public School District, the Princeton Education Foundation, and the Walnut Lane Film Festival. If Actor/Location receives any print, negative, or other copy thereof, Actor/Location will not authorize its use by anyone else.
- C. Actor/Location will not hold the Princeton Public School District, the Princeton Education Foundation, or the Walnut Lane Film Festival responsible for any liability resulting from the use of the Actor/Location's name, likeness, or photograph(s) in accordance with the



terms hereof, including what might be deemed to be misrepresentation of Actor/Location, Actor/Location's character, or Actor/Locations' person due to distortion, optical illusion, or faulty reproduction that may occur in the finished product.

- D. Nothing in this Agreement will constitute any obligation on the part of the Princeton Public School District, the Princeton Education Foundation, and the Walnut Lane Film Festival to make any use of any of the rights granted by Actor/Location under this Agreement.
